

Consent for the collection and transfer of biometric data

Biometric data are used in the process of producing individual protective equipment. We wish to transparently describe the data processing and production process below and request your consent for data processing.

Controller

Responsible for data processing is the employer.

Data collection and purpose of data processing

Current technology makes it possible to individually adapt reliable protective equipment to your medical needs. The first step is to collect your individual data. Depending on the desired protective product, it's necessary to collect various biometric data, such as:

- measurements of the eyes and visual acuity in order to produce individual protective glasses,
- performing a hearing test,
- individual ear impressions,
- measurement of the feet in order to produce customised inserts and safety shoes.

These data sets constitute biometric and/or health-related data with an elevated need for protection. Your data are therefore collected by trained professionals working for our partner companies. The provided or available opticians, auditory technicians and orthopaedists collect and process your data on their own responsibility – you are treated virtually like a regular customer.

If you have questions on the collection, associated data processing and the data protection provided in this process step, please consult the relevant partner company directly (e.g. the optician engaged to take the measurements).

Transfer

The biometric data are then sent to UVEX ARBEITSSCHUTZ GMBH, Würzburger Str. 181, 90766 Fürth, Germany, where they are used to produce individually customised safety products. During the course of manufacturing and shipping, other production partners of UVEX ARBEITSSCHUTZ GMBH may be integrated into the production process.

Secure processing of your data by the production partner of UVEX ARBEITSSCHUTZ GMBH is ensured by means of data protection agreements between UVEX ARBEITSSCHUTZ GMBH and the production partner, as well as by periodical checks. We ensure that we use exclusively reliable production partners – your data are processed within the EU and by a production partner in Switzerland. The EU Commission has determined a suitable level of data protection for Switzerland.

UVEX ARBEITSSCHUTZ GMBH is responsible for this data processing step. If you have any questions regarding data processing or data protection, please contact your appointed Data Protection Officer. He/she will immediately contact the Data Protection Officer at UVEX ARBEITSSCHUTZ GMBH.

Duration of storage

The personal data are only stored for as long as required according to statutory retention periods. If you revoke your consent or request deletion of your data before expiry of the statutory retention periods, your request will be considered on an individual basis.

Voluntary nature of consent / Necessity of the data

Of course, providing consent is entirely voluntary. If you do not give us consent for data processing, no occupational disadvantages will result for you. However, we ask for your understanding that we will not be able to produce individually customised protective equipment without collecting and processing biometric measurement data.

Revocation and rights of the data subject

Consent can be revoked at any time with future effect by contacting

Your Data Protection Officer will immediately contact the partner company collecting the data as well as UVEX ARBEITSSCHUTZ GMBH and inform them of your assertion of your rights as a data subject.

You have the right to file a complaint about this data processing with a data protection supervisory authority and subject to the statutory requirements, you can request information, correction, deletion or restricted use of your data; revoke consent for processing; or assert your right of data portability.
